Successful Entitlement Offer Completed

Following the announcement on 14 December 2010 that the 3 for 4 Entitlement Offer by Nomad Building Solutions Limited (“**Nomad**”) had closed fully subscribed, Nomad confirms that it has now issued the full 118,919,867 shares to be issued at \$0.10 per share pursuant to its Prospectus dated 15 November 2010.

The number of Nomad shares on issue now stands at 277,479,329.

A current listing of the 20 largest shareholders in Nomad accompanies this statement.

The Entitlement Offer was oversubscribed and cheque refunds were issued on 22 December 2010 to shareholders who applied for Additional Shares over and above their 3 for 4 entitlement and who had their applications for Additional Shares scaled back.

Adjustment to option exercise prices

As noted in section 4.2 of Nomad’s Prospectus dated 15 November 2010, the terms of all unlisted options issued by Nomad provide for the exercise price of the options to be adjusted in accordance with the formula set out in the ASX Listing Rules to account for the dilution impact of a discounted pro rata share offer. Nomad advises that the impact of this has been to reduce the exercise price of all options to acquire a new Nomad share by \$0.0211 per option.

A summary of the number of unlisted options on issue and the new exercise prices is as follows:
